Mayor Finney called the meeting to order at 7:00 PM and asked all those present to stand for the Pledge of Allegiance.

Correspondence

Email from Francine LaValle regarding First Street Sidewalks was received. Mayor Finney stated that there may be grants available for this.

Approve Minutes September 25, 2023

Motion was made by Mayor Finney, seconded by Trustee Cassidy to approve the minutes of September 25, 2023 as presented. Motion Passed.

Sgt. Sturtz presentation to the Board

Sgt. Sturtz presented two programs to the Village Board – Lexipol Implementation Information Brief and a wellness program.

He presented the agenda as follows: Policing in 2023 and beyond challenges, NYS Accreditation, Wellness program, Lexipol Overview and cost.

There are many challenges facing policing 2023. There is transparency, training, policy review and management, third party review and understanding best practices

Sgt Sturtz currently works on the police department's accreditation. The current estimated cost to prepare documents is approximately 25% of his salary, which is approximately \$20,500. Lexipol policy and

accreditation cost for the first year implementation is \$29,772.05. After the first year, the annual prescription cost of \$10,699.85.

Lexipol creates policies with the intent to decrease risk and preserve life. Lexipol is successful since they are a non-biased third party that brings forth best practices from around the Country. This ensures that departments like Liverpool are provided an outside perspective with an eye to checks and balances. Lexipol has created a variety of health and wellness information, fitness programs, yoga videos and the ability to discretely speak to a mental health professional. Mental health issues are a huge concern for police officers and their families. This wellness program annual subscription cost is \$1,999.

Sgt Sturtz requested that the Board consider these programs at a first year cost of \$30,000.

The Board of Trustees intends to move forward but will need a formal contract to be reviewed by the attorney.

Sgt Sturtz will reach out to Lexipol and forward the contract to the Mayor and attorney. This will be on the November agenda.

Public comment

Kelly Romano wanted to inform those present about a book called "Secret Syracuse". It contains articles about the Village and is a very good book.

Introduce Local Law E- 2023 (A Local Law to Amend Article I of Chapter 342 of the Code of the Village of Liverpool Regarding Tax Exemptions on Real Property Owned By Persons Sixty-Five Years Of Age or Over Pursuant to Real Property Tax Law § 467)

Mayor Finney introduced proposed Local Law No. E-2023, "A Local Law to Amend Article I of Chapter 342 of the Code of the Village of Liverpool Regarding Tax Exemptions on Real Property Owned By Persons Sixty-Five Years of Age or Over Pursuant to Real Property Tax Law § 467" and made the following motion, which was seconded by Trustee Ciotti:

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Village of Liverpool, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQR) with respect to the proposed enactment of said Local Law, with the result that the Village Board shall act as lead agency in this matter; and

WHEREAS, the adoption to said Local Law is an unlisted action for purposes of environmental review under SEQR; and

WHEREAS, the Village Board has determined that a short environmental assessment form (EAF) shall be required in connection with this matter; and

WHEREAS, the said EAF has been prepared and has been reviewed by the Village Board; and

WHEREAS, the Village Board has considered the adoption of said Local Law, has considered the criteria contained in 6 N.Y.C.R.R. Part 617.7 and has compared the impacts which may be reasonably expected to result from the adoption of said Local Law against said criteria.

NOW, THEREFORE, it is

RESOLVED AND DETERMINED, that the enactment of proposed Local Law No. E-2023 is an unlisted action, there are no other involved agencies and this Board shall act as lead agency in this matter for purposes of SEQR review; and it is further

RESOLVED AND DETERMINED, the Village Board has determined this action shall have no significant adverse impact on the environment; that, accordingly, an environmental impact statement (EIS) shall not be required; and that this resolution shall constitute a negative declaration under SEQR; and it is further

RESOLVED, that the Village Board shall conduct a public hearing as to the enactment of proposed Local Law No. E-2023 at the Village Hall located at 310 Sycamore Street, Liverpool, New York on November 20, 2023 at 7:01 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard; and it is further

RESOLVED AND DETERMINED, that notice of said public hearing shall be provided at least five (5) days prior to the date of said public hearing in a newspaper of general circulation within the Village of Liverpool and to any affected municipalities described above.

Resolution providing that the Village of Liverpool Elections shall be conducted by the Onondaga County Board of Elections subject to permissive referendum

Mayor Finney introduced this Resolution providing that Village of Liverpool elections shall be conducted by the Onondaga County Board of Elections and made the following motion, which was seconded by Trustee Cassidy:

WHEREAS, historically, the Village of Liverpool has conducted its own elections pursuant to Article

3 of the New York State Village Law and Article 15 of the New York State Elections Law at significant cost
to the Village; and

WHEREAS, the Village has determined that the time has come to transfer the conduct of Village Elections to the County Board of Elections, the local board charged with this responsibility and the entity best positioned to conduct elections in a professional and efficient manner; and

WHEREAS, the County Board of Elections will receive nominating and other petitions in accordance with law and provide all publication and notices required by law and compensate all election workers in accordance with law; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the adoption of a resolution in the Village of Liverpool, such that there are no other involved agencies

within the meaning of the New York State Environmental Quality Review Act (SEQR) with respect to the proposed Resolution, with the result that the Village Board shall act as lead agency in this matter; and

WHEREAS, the adoption of said Resolution is an unlisted action for purposes of environmental review under SEQR; and

WHEREAS, the Village Board has determined that a short environmental assessment form (EAF) shall be required in connection with this matter; and

WHEREAS, the said EAF has been prepared and has been reviewed by the Village Board; and

offices and any special elections shall be conducted by the Onondaga County Board of Elections following the adoption of this Resolution; and it is further

RESOLVED AND DETERMINED, that this Resolution is subject to permissive referendum as provided by Article 9 of the New York State Village Law.

EDR- Comprehensive Plan & coordinating with the Town of Salina

Mayor Finney stated that Town of Salina is moving forward with EDR and the comprehensive plan for the Town. The Village of Liverpool adopted our comprehensive plan in 2006 and it is in need of updating. EDR's original proposal was to create a new comprehensive plan for the Village. Mayor Finney stated that there are grants available to help fund the cost of the Comprehensive Plan.

Trustee Cassidy stated that she feels that this is not a priority at this time. The \$70,000 budgeted for the updating could be used for other purposes. She feels that this could be looked at again a year from now.

Trustee LaMontagne stated that the Board asked EDR to take a better look at our current comprehensive plan and give us a better idea of how much it would cost to update. The Village has not had any update yet from EDR. He stated that this is only one quote and that there could be other companies that do this.

Trustee Ciotti stated that she is all in favor of working with the Town of Salina and how can we do it without the high cost being presented for the Comprehensive Plan.

Trustee LaMontagne stated that he is all for updating the plan but we need a more definitive cost.

This will be on a future agenda.
