A regular meeting of the Village of Liverpool Board of Trustees was held on November 20, 2023 at 7:00 PM at 310 Sycamore Street, Liverpool NY. This meeting was open to the public.

Also present was Judge LaValle, Chief Unger, Sgt Sturtz, members of the Police Dept., Russ Tarby and approximately 10 other persons.

Mayor Finney called the meeting to order at 7:00 PM and asked all those present to stand for the Pledge of Allegiance.

Swearing in of Officer Ottaviano

Mayor Finney requested Officer Ottaviano to come to the front of the room for his swearing in ceremony. Officer Ottaviano's mother Christine Chwalow held the Bible for him. Mayor Finney asked Officer Ottaviano to repeat the oath of office after her. Chief Unger and members of the Liverpool Police Department, along with all those present congratulated Officer Ottaviano.

Reschedule December and January meetings

Motion was made by Mayor Finney, seconded by Trustee LaMontagne, to reschedule December 18th meeting to December 11th at 7:00 PM and to reschedule January 15th meeting to January 22nd at 7:00 PM. Motion Passed.

Approve/deny Lexipol & Wellness Program

At the Village Board meeting in October, Sgt Sturtz presented the Lexipol and Wellness programs for the police department.

There are many challenges facing policing 2023. There is transparency, training, policy review and management, third party review and understanding best practices

Sgt Sturtz currently works on the police department's accreditation. The current estimated cost to prepare documents is approximately 25% of his salary, which is approximately \$20,500. Lexipol policy and Accreditation cost for the first year implementation is \$29,772.05. After the first year, the annual prescription cost of \$10,699.85.

Lexipol creates policies with the intent to decrease risk and preserve life. Lexipol is successful since they are a non-biased third party that brings forth best practices from around the Country. This ensures that departments like Liverpool are provided an outside perspective with an eye to checks and balances. Lexipol has created a variety of health and wellness information, fitness programs, yoga videos and the ability to discretely speak to a mental health professional. Mental health issues are a huge concern for police officers and their families. This wellness program annual subscription cost is \$1,999.

Sgt Sturtz requested that the Board consider these programs at a first year cost of \$30,000.

Trustee Devendorf stated that he is in favor of these programs for the police department. He feels that our police personnel need to be actively keeping our citizens safe and should be on the streets, not pushing massive amounts of paperwork to keep up with the accreditation. He stated that the Village board should find a way to make it happen financially.

Mayor Finney is in support of these programs Lexipol represents thousands of municipalities.

Trustee Ciotti questioned how the Village can afford to pay for it. She asked, if perhaps, these programs could be pushed out a few months. She asked if it would be possible to split the cost into monthly payments.

Trustee Cassidy stated that she fully supports these programs however, feels that the funds to pay for it may put a burden on the current year's budget.

Mayor Finney stated that there is \$47,000 left in ARPA funds and that the expenditure could be funded with that money.

Motion was made by Mayor Finney, seconded by Trustee Devendorf, to approve the Lexipol and Wellness Programs for the Police Department for a first year cost of \$29,772.05, with an annual cost after first year of \$12,698.85, with first year cost of \$29,772.05 coming out of the ARPA monies remaining, contingent upon attorney review.

7:01 Pm Public hearing Local Law E- 2023 " A local law to amend Article 1 of Chapter 342 of the Code of the Village of Liverpool regarding tax exemption on Real Property Owned by persons sixty-five years of age or over pursuant to Real Property Tax Law Section 457.

Motion was made by Mayor Finney, seconded by Trustee LaMontagne, to open the public hearing on Local Law E- 2024.

Attorney Andino recapped this local law. This local law raises the income levels for persons over 65 that owns a home in the village to the maximum amount of \$58,400. If the Village adopts this law, they will be in line with the Town of Salina and Onondaga County. The current maximum income level is \$37, 400.

Hearing no more questions or comments, Mayor Finney made the motion to close the public hearing, seconded by Trustee LaMontagne. Motion Passed.

Motion was made by Mayor Finney, seconded by Trustee Ciotti, to adopt Local Law E- 2023, now known as Local Law 5-2023 as shown below:

Be it enacted by the Village Board of Trustees of the Village of Liverpool as follows:

SECTION 1. LEGISLATIVE INTENT & PURPOSE

The Village Board of the Village of Liverpool, being ever mindful of its responsibility and obligation to provide for the welfare and financial independence of the senior citizens of the Village who have made a vital contribution to the growth, development and progress of the community, intends by the enactment of this Local Law to provide protection for limited income senior citizen homeowners from the increased cost of living.

The purpose of this Local Law is to amend the current Article I of Chapter 342 of the Code of the Village of Liverpool to update the exemptions from taxation in accordance with the criteria set forth in New York State Real Property Tax Law §467.

SECTION 2. AUTHORITY

The adoption of this Local Law is in accordance with Section 10 of New York's Municipal Home Rule Law and New York Real Property Tax Law §467.

SECTION 3. AMEND ARTICLE I OF CHAPTER 342 OF THE CODE OF THE VILLAGE OF LIVERPOOL

Article I of Chapter 342 of the Code of the Village of Liverpool shall be repealed in its entirety and replaced with the following:

"§342-1. Exemption granted; Amounts.

A. Real property in the Village of Liverpool owned by one or more persons, each of whom is 65 years of age or over, or real property owned by spouses or by siblings as

defined by Real Property Tax Law §467, one of whom is 65 years of age or over, shall be exempt from taxation by the Village to an extent as set forth in Subsection B of this Section based on their income. Such exemption shall also apply to real property in which a person(s) holds a legal life estate or which is held in trust solely for the benefit of a person(s) if such person(s) would otherwise be eligible for the exemption were such person(s) the owner(s) of such real property.

B. A graduated tax exemption shall be allowed in accordance with the following schedule:

§342-2. Compatibility with Real Property Tax Law §467.

The right to said exemption set forth in this Chapter, the procedures for application therefor and the restrictions and limitations thereon shall be as set forth in this Chapter in accordance with the terms, procedures, restrictions and limitations set forth in the Real Property Tax Law §467. The exemption, the procedures for application therefor and the restrictions and limitations thereon as set forth in Real Property Tax Law §467, as amended, and as from time to time shall be amended, are hereby incorporated by reference into this Chapter. If any provisions of this Chapter are in conflict with those set forth in Real Property Tax Law §467, Real Property Tax Law §467 shall be controlling."

SECTION 4. SEVERABILITY

If any clause, sentence, paragraph, section, article or part of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operations to the clause, sentence, paragraph, section, article, or part thereof directly involved in the controversy in which such judgment shall have been rendered.

SECTION 5. EFFECTIVE DATE

This Local Law shall take effect upon filing with the Secretary of State."
